Intellectual property of the Axxès company:

1. Liability of Axxès

Warning: The results provided by the simulator and the information contained on the Site are presented to the user purely for information and guidance purposes. The user acknowledges and accepts that these simulations and this information may contain inaccuracies and, in particular, may not correspond to the amounts of fees, taxes or other tolls the user will actually

have to pay to the relevant organisations. The user thus understands and accepts that Axxès cannot be held liable for any inaccuracies or errors on the Site.

The user is informed that access to all or part of the Site may be interrupted or suspended by Axxès for maintenance purposes or corrective action.

In addition, given the risks inherent in use of the Internet, the user acknowledges and accepts that Axxès cannot be held liable for any suspensions or interruptions to access to the Site, errors or bugs, the presence of computer viruses or fraudulent intrusions by third parties that have changed the information presented on the Site or for their consequences for the user.

2. Content posted by users of the Site:

Transfer of rights to user content: When the user posts content on the Site, the user agrees to transfer to Axxès all rights to this content in all media, existing or future, including paper and digital, magnetic, optical or videographic media (the "**Media**"). The content may consequently be used both for the needs of the Site and for all of Axxès' activities including its relations with its partners, and in particular it may be:

- reproduced by any process in any Media;
- represented in any way in any Media;
- adapted and translated in any Media.

This transfer is granted by the user to Axxès free of charge for the whole world and throughout the legal duration of the intellectual property rights.

3. User liability:

Axxès reminds the user that the content posted must comply with the law and regulations in force. In particular, users must not post:

- content breaching the intellectual property rights of third parties;
- information enabling natural persons to be identified directly or indirectly without their consent;
- content which by its nature is defamatory, insulting, pornographic or violent or incites discrimination or violence;
- information of a commercial nature or information that promotes a regulated product or service such as tobacco, alcohol or any other substance;
- in general, content that breaches public order or morality.

CONFIDENTIALITY POLICY:

The information collected via the Site is processed electronically for statistical purposes and in response to your requests for documents or information, particularly in the context of the use of the simulator.

This processing has been declared by Axxès to the CNIL (the French data protection authority).

To ensure the best possible service for the user, Axxès may carry out Site audience measurement using cookies.

We remind you that cookies do not enable users to be identified. Cookies store information about how users browse the Site on their computer, smartphone, tablet or other connected device, such as the pages viewed, the order in which they were viewed and the time and date.

The information collected by the cookie is read when users return to the Site. The information collected by cookies on the user's connected device is conserved for 1 year.

Axxès also reminds the user that information about their searches and browsing may be processed or passed on for the purposes of targeted advertising by Axxès or its partners, in full compliance with the law on data protection. Cookies are used for purposes associated with advertising, statistical measurements, geographically specific advertising and the analysis of the user's behaviour in order to personalise advertising aimed at them.

Information for users about how to reject cookies:

Axxès informs the user that the recent versions of the main web browsers make it possible not only to refuse to store cookies but also to operate browsing sessions after which all cookies stored during the session are automatically deleted independently of their scheduled conservation period, providing better protection against tracking.

The user also has access to tools for managing cookies, including:

- blocking cookies from "third-party" sites, i.e. cookies stored by a site other than the site displaying the main content,
- creating "blacklists" of sites on which cookies should be blocked.

Rights to access, correct and object to information for legitimate reasons

In accordance with French law 78-17 of 6 January 1978 amended in 2004 on data protection, the users of the Site have the right to access and correct data held about them. Users may also object to the processing of their data for legitimate reasons.

All users are informed that Axxès may only use the information collected within the strict framework of the authorisation granted by the user.

The information collected is used for purposes including enabling Axxès to manage shareholding and registrations and to send newsletters to registered users' e-mail addresses, together with commercial offers from Axxès and, where relevant, its commercial partners if the user has given his or her express consent (including by ticking a box).
